("Retif") having given or extending in the future terms of credit to _____ ("Customer") from time to time, it is hereby agreed _____ ("Guarantor") does hereby guaranty to Retif or its successors the full payment of all monies owed to Retif from Customer without limit, plus interest, fees and charges of whatsoever nature and kind, waiving all notice and pleas of discussion and division. Without further authorization from or notice to Guarantor, Retif may grant credit to Customer from time to time. Guarantor acknowledges that this guaranty also applies to all prior outstanding obligations and further obligations of Customer to Retif.

This guaranty is unlimited as to amount or duration and shall remain in full force and effect notwithstanding any extension, compromise, adjustment, forbearance, waiver, release or discharge of any party obligor or guarantor, or release in whole or in part any security granted for said indebtedness or compromise or adjustment thereto and Guarantor waives all notices thereto.

The obligations of Guarantor shall be at the election of Retif, shall be primary and Retif shall not be required to exhaust its remedies as against Customer prior to enforcing its rights under this guaranty against Guarantor.

The guaranty hereunder shall be unconditional and absolute, and that acceptance and notice of acceptance thereof by Retif are therefore unnecessary and hereby expressly waived. Guarantor waives all rights of subrogation and set off until all sums under this guaranty are fully paid. In the event payments due under this guaranty are not paid upon demand, Guarantor shall pay all reasonable costs and attorney's fees necessary for collection and enforcement of this guaranty.

This guaranty shall be construed and enforced under the laws of the State of Louisiana and shall be binding upon Customer's successors and assigns.

ADDITIONAL TERMS FOR CARDLOCK USE

1. Purchaser shall be responsible for all purchases using cardlock cards issued to Purchaser.
2. If there is any change in the ownership of Purchaser or if substantially all of the assets of Purchaser are sold, Purchaser shall promptly notify Supplier of such sale and Supplier shall have a lien on all assets of Purchaser and a lien on the proceeds of such sale to secure payment of all outstanding sums owing to Supplier.
3. Purchaser represents that it and any person using the cardlock cards delivered to Purchaser are and shall be aware of the proper use of the cardlock system and shall use safe use practices in compliance with regulations of the local Fire Code in the handling of the fuel dispensed from the cardlock system. Purchaser agrees to indemnify and hold Supplier harmless from any claims and costs including, but expressly not limited to, those for bodily injury and property damage which may be occasioned by the negligence or misuse of the cardlock system and of Supplier's cardlock premises and equipment, by Purchaser or any person using the cardlock system with cardlock cards delivered to Purchaser hereunder.
4. Supplier shall use its best efforts to maintain the cardlock system in good working order and condition at its expense provided; however, Supplier shall not be responsible for any damages or loss which may result from its failure to provide fuel or the failure of the cardlock system in any manner whatsoever. Purchaser agrees that it and the cardlock system of which Purchaser or such person is aware.
5. Purchaser's right to purchase fuel through the cardlock system may be terminated upon any breach of any terms hereof or of any other agreement with supplier. Upon termination, Purchaser agrees to immediately surrender all cardlock cards issued to Purchaser and to immediately pay all outstanding sums owing to Supplier. Supplier shall refund any deposit to Purchaser when all cards are returned and all amounts owing to supplier are paid in full.
6. In the event of a breach of any of the terms of this Agreement or any other agreement between Purchaser and Supplier, including but expressly not limited to the failure to pay sums owing to Supplier when due, then in addition to any other sums due or payable to supplier by Purchaser, Purchaser agrees to pay the reasonable attorney fees and costs incurred by Supplier in the enforcement of Supplier's rights even though no suit or action is filed and if suit or action is filed to enforce the rights of Supplier, then such further sum as the court may adjudge reasonable as attorney fees at trial or an appeal of such suit or action in addition to all other sums provided by law.
7. All terms and conditions of this Agreement and Guaranty are intended to cover Purchaser's account, as well as all of the Purchaser's branch accounts whether set up now or in the future.
8. Purchaser's account may be subject to deposit requirement.
9. Purchaser's credit limit may be increased or decreased at the discretion of Supplier.
10. Any discounts to Purchaser on the per gallon price is only applicable if payment is received by the due date set forth on the invoice.
11. This agreement shall be governed and constructed in accordance with the laws of the State of Louisiana.
12. This Agreement shall become effective upon acceptance by Supplier.
